March 27, 2021

Via Zoom Teleconferencing due to COVID-19 restrictions

1. Call to order:

Richmond is no longer charging fines, and there is a new library going into Steveston.

8.2 Sunshine Coast Regional District (SCRD) Report: Lori Pratt

SCRD 2021-2025 Financial Plan Bylaw was adopted on March 25, 2021. There are 213 projects on top of the regular operations. Link to the press release:

SCRD director-led information sessions for the public and Zoom proved to be an effective tool for increasing public participation in the process.

Area Planning Commission Orientation Sessions are proceeding this week and next to familiarize volunteers with their roles.

The Planning Department is launching several improvement processes to help make efficiencies and improve staff capacity and service to the public.

8.3 District of Sechelt (DoS) Report: Janice Kuester

The DoS' alternate approval process to go ahead with seeking a loan for its public works building passed, so DoS will be going to the next step for financing.

DoS is in the midst of its budget review. The District has received a lot of grants, which means that they will be hiring more staff to accomplish the work going forward.

The Ministry of Transportation approved the funding and extension of 700 ft at the airport to improve safety and allow larger aircraft to come into Sechelt. Resurfacing of the tarmac needs to be done and will be done as part of this project.

A lot of community groups attended the emergency housing meeting recently to discuss the crisis the Sunshine Coast is in with its lack of affordable housing and rental units. Many tenants are being evicted with the surge in real estate sales, and there is nothing to rent. This group is meeting again on April 19 to report back about immediate, short-term goals while looking for longer-term solutions to affordable housing on the Coast.

8.4 Treasurer's Report

Beverly Shimazaki/Ruth Moore: To accept the February Financial Statements as reported. CARRIED

Beverly Shimazaki walked board members through the revised December 2020 Financial Statement. The big adjustment was the calculation of the \$32,821 depreciation expense by James + McIntyre. Beverly Shimazaki/Rhian Piprell: To accept the revised December 2020 Financial Statements as reported.
