- Council approved Development permit for our Ops Building
- Wharf sidewalk improvement awarded funded from a grant BC Infrastructure Active Transportation Grant
- Third reading zoning amendment and OCP bylaw for Telus living six-story mixed use 60 residential units (question arose as to this property being market rental or affordable housing rental Janice will let Board know by email)
- Applying for Grant for sewer expansion to West Porpoise Bay
- Hot topics STR bylaw next presentation March 1. Survey available. Kinnickinick Fields allowing dogs or not
- Council voted on two new APC members and two new grant review members
- Sunshine Coast Drag Racing request to use Airport engineering to give report on implications and costs at next Council meeting
- Next Intergovernmental meeting held at end of March
- AVICC being held in Victoria on April 1-3 (Association of Vancouver Island and /Coastal Communities) Annual general meeting and convention where members are provided opportunity to bring forward issues and concerns from their communities through resolutions and debates.

8.3 Sunshine Coast Regional District Report: Leonard Lee

- Supportive/Affordable housing 4 units and 104 firefighters in Pender Harbour
- Health benefits approved for 104 volunteer fire fighters
- Budget approved with 7% increase. SCRD will be paying 14% higher portion from previous year.
- Asking that Elfinstone site be removed from the allowable log cut
- All agree that there should be affordable housing, but nobody agrees on where the zoning boundary should be. Three times requests for density change of zoning have been denied, because of response from the neighbours.
- Rotary Club has received permission to go ahead with the Story Book Walk in the Forest.

8.4 Treasurer's Report: All funding is now in place for this time of year. The Library Director explained the reasoning for separating damage repair for technology items and damage repair for books.
